




## Where Do I Start?

- Building your campus school safety team
  - Multi-disciplinary approach
    - Administrator(s)
    - Counselor
    - Social Worker
    - School Nurse
    - Teachers
    - Custodian
    - Students
    - External Partners Law Enforcement, Fire, EMS, Emergency Management, Hospitals, Juvenile Court, etc.

#### **Family Reunification**

- Are you using another school?
- Do you have an existing MOU with your reunification site?
- How will you direct parents to the new location?
- Have you traveled the path with your safety team?
- Can the location be secured by law enforcement to assist in an orderly reunification?
- Will interviews be necessary prior to student release?
- How would you handle a student that's unaccounted for?



## Communications

#### How do you communicate with your stakeholders?

- Internal
  - During an emergency, how do you communicate with your staff and students?
    - Overhead announcements (Plain Language)
    - Radio
    - E-mail
    - Mass Notifications System
- External
  - During the same emergency, how do you communicate with local first responders, parents and community members?
    - E-mail
    - Website
    - Mass Notifications System
      - Does your system require an individual to opt-in?
- Do you have pre-scripted messages that can be used?

- The School Safety Hotline is an anonymous, toll-free, 24-hour hotline designed for crisis prevention.
- Callers pass on information through the Hotline initiating immediate and appropriate action by operators with the Georgia Department of Public Safety.
- Hotline reports are forwarded to GaDOE for follow-up.
- Over 80% of Hotline calls are related to bullying.



### **Bullying Prevention Toolkit**

#### **Bullying Prevention**

Many school districts are seeking tools to use in the development of bullying prevention strategies and activities. The purpose of this webpage is to provide information to aid efforts to prevent and respond to bullying behavior.

#### **Georgia's Bullying Law**

In 2015, the Georgia General Assembly expanded the definition of bullying through House Bill 131, also known as "The End to Cyberbullying Act". HB 131 modifies the definition of bullying to include acts of cyberbullying which occur through the use of electronic communication, whether or not such electronic act originated on school property or with school equipment. # 2023 Legislative Updates School Safety

#### **Passed By Both Chambers:**

- HB 147 'Safe Schools Act' requires intruder alert drills in all public schools: provides for a school safety and anti-gang endorsement to be issued by the Professional Standards Commission for eligible certified personnel
- HB 18 Amended FY23 Appropriations Bill provides funds for security grants in the amount of \$50,000 per school for school security enhancements (Signed by Governor Kemp)
- HB 402 Requires public schools to provide water safety education information upon initial enrollment to parents and guardians of students under 18 years of age, and directly to students 18 years of age and older
- HB 440 Authorizes public and private schools to stock a supply of undesignated ready-to-use glucagon
- SB 45 Provides for the implementation of seizure action plans; requires GaDOE to develop training guidelines and model seizure action plans

#### **Did Not Pass**

• SB 32 - 'Alyssa's Law' requires local education agencies to implement a mobile panic alert system capable of connecting disparate emergency services technologies to ensure real-time coordination between multiple state and local first responder agencies in the event of a school security emergency.

## House Bill 147

- Intruder Drills must be completed by October 1<sup>st</sup> of each year
- Each school is encouraged to work with your local school board, emergency managers, emergency responders and school staff to design a drill representing a scenario based on your school needs

## House Bill 147

 The Safe Schools Act requires all public schools to submit school safety plans to their local emergency management agency, local law enforcement and GEMA-HS for approval



### House Bill 147

- School Safety and Anti-Gang endorsement
  - A collaborative effort amongst:
    - Georgia Emergency Management & Homeland Security Agency
    - Georgia Department of Education
    - Georgia Public Safety Training Center
    - Georgia Department of Juvenile Justice



## **FY23 Security Grants**

- Signed by the Governor on March 10, 2023
- Provides \$50,000 for each public school in the state to enhance campus security
- Limited to equipment, training and infrastructure improvements
- Managed via reimbursement for relatable expenses incurred after March 10, 2023
- Reimbursement requests must be submitted no later than March 1, 2024

- Security Related Training



## **Employee Assistance Update**

- Beginning August 1<sup>st</sup> 2023, all campus-based School Resource Officers will become eligible to receive services from the Georgia Public Education Employee Assistance Program
  - Programs that are available include:
    - Legal Consultation
    - Financial Consultation
    - Child and Elder Care Referrals
    - Confidential Counseling


